Grievance Arbitration: The fee is \$950 for each full or partial hearing day and for each day of study and preparation of the opinion and award. A hearing day is any portion of a day up to eight (8) hours. Partial days necessary for study and award preparation will be prorated.

Interest Disputes including mediation, fact finding, interest arbitration and similar proceedings: \$1250 for each full or partial hearing day and for each day of study and preparation of the opinion and award. A hearing day is any portion of a day up to eight (8) hours. Partial days necessary for study and award preparation will be prorated.

Cancellation: A full per diem fee will be charged for each scheduled day of hearing canceled, continued or postponed with notice by any party for any reason 4 calendar weeks (28 days) or less prior to each such date. For a hearing scheduled for three (3) or more days, a notice period of six calendar weeks (42 days) will apply.

Travel Costs: Arbitrator charges per diem fee for any portion of a travel day over four (4) hours. Travel time of less than four (4) hours will be charged ½ the per diem. The per diem fee is prorated for travel time over eight (8) hours for one day at \$118.75/hour.

Expenses: Arbitrator charges actual cost of reasonable expenses, including airfare, car rental, hotel and meals. Automobile mileage is charged at the applicable IRS expense rate. Arbitrator does not usually charge for copying, distribution and normal office charges relating to the preparation of the award, but may charge for extensive phone calls, e.g., teleconferences.
