Fee:

Per Diem: \$2000 per day for hearing, research and presentation of the decision.

A hearing day is any portion of a day up to eight hours. Time for research and preparation is prorated.

Cancellation Policy: \$2,000 for one day per diem if cancelled within days of scheduled hearing date.

Travel Time: One-half day per diem fee for any portion of a travel day up to four hours. One day per diem fee for travel day between four and 8 hours. Fee is prorated for travel time over eight hours at \$250/hour. No fee for local travel within 50 miles.

Expenses: Actual cost of reasonable expenses, including airfare, car rental, food and lodging. Automobile mileage is charged at the applicable IRS expense rate. Interim Billing: Periodic invoices may be issued when there are cancellations or multiple hearing dates.
